ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2004, the Northern Regional Committee has notified the Regulations, 2014 on 01.12.2014,

AND WHEREAS, the institution i.e. **Choudhary Charan Singh T. T. College, NH -11, Shree Ram Nagar Colony, Ronli, Sikar, Rajasthan** has been recognized for B Ed by NCTE vide its order dated 17.09.2008 (RJ-174/2008/62538-544 dt. 17.09.2008 for an intake of 100)

AND WHEREAS, the institution **Choudhary Charan Singh T. T. College, NH -11, Shree Ram Nagar Colony, Ronli, Sikar, Rajasthan** has by affidavit consented to come under the Regulations in B Ed, which require additional facilities,

AND WHEREAS, it has been decided to permit the institution two basic units of 50 students each subject to the following conditions namely,

The institution shall create additional facilities which include (a) additional basic structure and hostel infrastructure, (b) additional funds, (c) adherence to state norms as per Regulation 2014 and inform the Regional Committees with required documents by October 31, 2015. The applicant Institution, for additional unit will be required to submit the required documents such as land documents, Non-Encumbrance Certificate (NEC), Land Use Certificate (LUC), the Building Plan (BP) in the format available on the website, to the Regional Committee in proof of having provided additional facilities, before October 31, 2015. Building Completion Certificate (BCC) can be given along with other documents, if available, otherwise it may be submitted at the time of inspection.

The Regional Committee shall arrange for verification of documents, inspection of the institution and compliance to these conditions by 20 February, 2016. If it is found that the institution fails to comply with these requirements, the institution shall be debarred from admitting students for the academic year 2016-2017.

If any existing institution's matter is sub-judice under court or law suit or any other legal proceeding, or if any complaint is pending, the institution shall be required to submit a copy of the court order or the complaint already submitted along with the documents. If the institution is referred to the court or law suit, the institution shall be required to submit the required documents as per provisions of the Regulations, 2014 within a period of one month from the date of the order of the court or law suit.

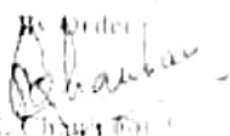
Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body/State Govt. etc. The institution shall also be required to submit to the affiliating body (University/State Govt.) all the documents as well as appointment of requisite staff as per provisions of the NCTE Regulations, 2014 by the concerned authority.

7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

- (a) Sanctioned programmes along with annual intake in the institution.
- (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) List of faculty members who left or joined during the last quarter.
- (d) Names of students admitted during the current session along with qualification, Percentage marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (e) List of students dropped from students.
- (f) List of infrastructural facilities.
- (g) Expenses incurred during the last quarter.
- (h) Number of books in the library, journals subscribed to and additions, if any, during the last quarter.
- (i) The Affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information, if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Regulations and Orders made and issued there under, the institution will render itself liable to be dealt with including withdrawal of recognition by the Regional Committee under the provisions of Section 10 of the NCTE Act.
